NOTE: Children under 1.15m in height are only allowed to participate in the Discovery area. Children under 12 must always be supervised by a responsible adult. Minimum height 1.05m and age 4 for Discovery, 1.15m for the RANGERS circuits, 1.25m for the EXPLORADOR circuit, 1.40m for the AVENTURA / THRILLER circuits, and 1.60m and **age of 16 years old** for EXTREME.

The Park proposes activities such as "Tree-to-Tree Adventure Park" and/or Team Building Activities and/or Fitness Activities, which set very strict conditions for participation in accordance with the safety rules specified to the practice of this activity. The preliminary and safety rules are shown before registering and during the introduction course and the risks inherent to the activity must always be borne in mind. I, the undersigned, in consideration for me and my dependent(s) subsequent, informed and voluntary participation in the above activities, do hereby willfully acknowledge that my signature below attests to my understanding and agreement that:

1. I understand and accept that these activities can be strenuous and dangerous. During my and/or my dependent (s) participation, I or we may be exposed to a variety of risks, both seen and unforeseen. I/we are fully aware of the services and activities provided, equipment and/or other facilities offered at the Park. I/we are also fully aware of my and/or my dependent(s) physical limitations.

2. I acknowledge that any misuse of the equipment or disregard for the rules and regulations can result in severe injury. My use and/or dependent(s) use of the Park facilities is undertaken in accordance with the rules and conditions displayed throughout the Park and communicated by staff during the activity and safety briefing and practice session. I understand that disregard of these rules and conditions may result in suspension of participation in the activities offered.

3. I individually and on behalf of my dependent(s) understand that the activities carried out at the Park involve inherent risk and entail a physical, contact sport that involves the risk of injury. I assume all risks and hazards associated with my and/or my dependent (s) participation in the above activities. I warrant that I and my dependent(s) are in proper physical condition to participate in such activities and games and have no illness, disease or any medical condition, existing injury or physical defect that would impair and/or aggravate my and/or my dependent(s) participation in the activities. I will inform the Park's staff if this status changes. I further acknowledge that this risk may involve loss or damage to me or my property, including the risk of death, or other unforeseen consequences, including those which may be due to the unavailability of immediate emergency medical care. I further warrant that I and/or my dependent(s) do not suffer from any heart condition, epilepsy, allergies, skeletal condition, spinal or any other medical condition which may result in potentially placing myself and/or my dependent (s) in a position of risk by participating in the abovementioned activities.

4. I am aware that I take responsibility for my actions and the actions of my dependents covered by this waiver form and accept that non-compliance with any of the park rules or instructions from park staff may result in the interruption of the duration of the activities applied for and possible ejection from the venue. These rules include but are not limited to: safety rules and regulations, height and restrictions, possession of prohibited items including alcoholic drinks or weapons and any actions that may be considered dangerous or inconsiderate to myself, other participants or staff.

This includes owners, lessors, and lessees of premises, municipalities, government agencies, successors, heirs, and assigns, if applicable. I also agree not to pursue any form of legal action for any, and all liabilities and claims that I and/or my dependent (s) might have arising from the participation in the activities or use of the equipment and facilities of the Park or medical costs. I, and on behalf of my dependent (s), have completely read and fully understand the terms of this Release of Liability and Assumption of Risk Agreement and hereby agree to indemnify the Park/Releasees for any and all litigation that may be brought up by and on behalf of my dependent(s). A form of identification for the material might be asked for, returned upon receipt of the equipment. The particulars on your ID card shall never be utilized.
